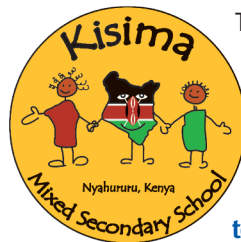

NORTHERN KENYA

TEFT supports Kisima School, a Kenyan charity working with people mainly from northern Kenya. Northern Kenya is a marginalised region, where most people live as nomadic pastoralists (herders who move their livestock from place to place in search of water and pasture), facing increasingly difficult living conditions. It borders similarly deprived Ethiopia, Somalia and Sudan, countries devastated by years of war and famine.

The region experiences recurrent drought, banditry, violent conflict and has virtually no public services. High percentages of the population are illiterate and depend on relief agencies for survival. Young people desperately need practical help to learn skills to overcome these challenges and bring new life to their communities and the region.

Through education and training Kisima School aims to help young people steer themselves out of dependence and marginalisation. Kisima School provides education to children from disadvantaged backgrounds who have proven academic potential to benefit from further learning. The school works to foster integration between the communities of northern Kenya and wider Kenyan society.

KISIMA SCHOOL

Opened in 2005, Kisima School is a free residential secondary school for 160 boys and girls aged between 14 and 18 years. School places are divided equally between male and female students.

Every single student achieved university entrance grades in last year's exams - the national average is 31%. Kisima School students will now embark on degrees including engineering, agriculture, analytical chemistry, HR management, international development, computer science, nursing, accountancy and teaching. A number of students have been awarded full scholarships to universities in Kenya and abroad, including China, Costa Rica, Poland and the US.

Increasing numbers of Kisima School alumni who have graduated from university have now returned to their home areas and are working in a range of employment including teaching, medicine, finance, engineering and IT. Many are paying for their siblings to attend school as they know education is the key to unlocking a new future for their families and communities.
